

- 3. All students living in the Edith Monture Elementary School, King George Elementary School, Major Ballachey Public School, and the Russell Reid Public School boundaries, and the bused students from James Hillier Public School would attend École Confédération Elementary School.

- All students living in the Edith Monture Elementary School, King George Elementary School, Major Ballachey Public School, and Russell Reid Public School, boundaries, and the bused students from James Hillier Public School would attend École Confédération Elementary School beginning September 2025.
- Approximately 70 students will be affected.
- There will be a Legacy option for students currently attending École Dufferin Public School. New siblings must enroll at École Confédération Elementary School.
- Transportation will continue to be offered for those Legacy students who are currently being provided with transportation.

#### D-1 Round Table

Superintendent Thompson facilitated the roundtable discussion about the presented options amongst working group committee members.

In response to an inquiry regarding transportation for students residing within the 1.6 km walking boundary but required to cross train tracks and walk along a road without a sidewalk, Superintendent Wyszynski stated that the matter will be thoroughly investigated.

In response to an inquiry regarding the availability of childcare at École Confédération Elementary School for families currently utilizing before and after school care at or near École Dufferin Public School, Superintendent Munro clarified that while the board cannot guarantee childcare services, it is actively collaborating with community partners to address and secure childcare options wherever there is a demonstrated need.

#### E-1 Next Steps

February 18, 2025 – Brantford Elementary FI Boundary Review – Working Group Meeting #2 will further discuss the proposed accommodation option, considering public feedback. The Working Group will make its recommendation to the Board of Trustees for approval.
