

PJCVS- Semester 1 Final Evaluations

Greetings PJCVS Families,

As we approach the end of semester one, I want to share some important information with you about final evaluations.

Important Dates:

- The last instructional day for regular classes is **Wednesday January 21, 2026**.
- Final Evaluations are scheduled to be completed from **January 22-28, 2026**.
- Students in self-contained program classes will attend school following their regular day schedule until **Monday January 26, 2026**. They will not return until the beginning of Semester 2 on **Monday, Feb 2, 2026**
- PA Days: **January 29 & 30, 2026** (no classes or scheduled activities for students).
- Semester Two classes begin on **Monday February 2, 2026**.

Final Evaluations:

All students are required to complete a final evaluation for each of their courses on their designated evaluation day. Final evaluations are scheduled for a minimum of 60 minutes and a maximum of 90 minutes. Extra time will be provided as per accommodations necessary for students with an IEP.

Final evaluations may be exams for some courses but could also include other types of evaluations suitable to course content, such as project-based activities, assignments, performance tasks, or other alternatives.

Thirty (30%) percent of a student's final grade is based on final evaluations administered at or towards the end of the course and may include evidence from one or a combination of summative activities. Teachers will communicate the details of all final evaluations with students and parents/caregivers in advance.

Credit Rescue:

The afternoon of each evaluation day will be reserved for students to complete course work to support credit rescue (revise and update any missed assignments/work). This is not necessarily applicable to all students, and teachers will inform students and parents/caregivers if attendance is required in the afternoon.

Evaluation Days Schedule:

Thursday January 22, 2026	Period 1 Courses
Friday January 23, 2026	Period 2 Courses
Monday January 26, 2026	Period 3 Courses
Tuesday January 27, 2026	Period 4 Courses
Wednesday January 28, 2026	Alternate day if needed due to inclement weather

- Final Evaluations: 9:00am – 10:30am
- Credit Rescue: 12:08pm – 2:46pm
- **Inclement weather day. If school is cancelled on an exam day then all of the exams will be pushed forward one day. For example, if we have a snow day on Friday, January 23 then Period 2 courses will have their exam on Monday, Period 3 courses will have their exam on Tuesday and Period 4 classes on the Alternate day on Wednesday.**

Buses will run on evaluation days following the regular schedule. Students who may be at the school for the full day, but without assigned credit rescue activities in the afternoon, are expected to be in one of the following supervised locations: Library Learning Commons or the Cafeteria. With parent permission, students are permitted to leave the school following the completion of their assigned daily activities.
