Topic Overview:

For many educators, dealing with problem behaviour in the classroom is a daily stressor that affects both the quality of the learning environment and job satisfaction. Educators often find themselves challenged by the volume of disruptive behaviour that they encounter. This may lead to a trial-and-error approach to managing problem behaviour, which could result in an overreliance on punitive methods.

In this workshop, school staff will learn how to analyze the "everyday" classroom variables that frequently contribute to problem behaviour. Participants well learn how to identify which variables could be changed. They will also learn how to develop and implement positive, evidence-based interventions at both the class and individual student level.

Learning Objectives:

- Analyze classroom variables that contribute to problem behaviours
- Implement evidence-based whole-class management strategies
- Identify common functions of classroom problem behaviours
- Identify common triggers for classroom problem behaviours
- Use information on function and triggers to plan and implement behaviour change interventions
- Troubleshoot common implementation problems and barriers
- Evaluate the effects of behaviour change interventions

Dr. Jennifer L. Austin, PH.D., BCBA-D

Dr. Jennifer Austin has been applying the science of behaviour analysis to improve outcomes for children and their teachers for over 20 years. Dr. Austin's research and clinical work focuses on how behaviour analytic assessment and intervention strategies can be applied with typically developing children and what adaptations may be necessary for making behaviour analysis work in mainstream classrooms.

Dr. Austin has worked with numerous schools in the United States and the United Kingdom, focusing on those in disadvantaged communities. She also works with schools and families to develop applied behaviour analytic programs for children with a range of behaviour challenges.
